



## Loader Job Description

**Job Title:** Loader

**Department:** Operation Manager

**Reports To:** Duty Manager/Operations Manager

**FLSA Status:** Non-Exempt

### SUMMARY

Responsible for safe loading and unloading of guests into and onto amusement rides by performing the following duties.

### DUTIES AND RESPONSIBILITIES

Other duties may be assigned.

- Ensures guests are safely loaded into gondola and carousel rides.\*
- Adheres to all safety guideline procedures and practices.\*
- Monitors attraction perimeter and restricted areas, such as the wheel, platform, ramps, access gate, and back area.\*
- Greets guests as they approach and exit the rides.\*
- Groups guests in to get maximum number for each ride.\*
- Maintains and cleans area.\*
- Serves as back up scanner.\*
- Assists guests with disabilities.\*
- Checks each gondola after each use for spills or items left.\*
- Performs other duties as assigned.

### QUALIFICATIONS AND REQUIREMENTS

- Minimum age is 16.
- Must be able to work various shifts as needed, including nights, weekends, and holidays.
- Must at least be in pursuit of High school diploma or equivalent.
- Ability to work in a fast-paced environment and maintain a positive attitude
- Excellent communication skills both written and verbal.
- Ability to read and comprehend simple instructions, short correspondence, and memos.
- Ability to write simple correspondence.
- Ability to effectively present information in one-on-one and small group situations to guests, clients, and other employees of the organization.
- Ability to add and subtract two-digit numbers and to multiply and divide with 10's and 100's.
- Ability to perform these operations using units of American money and weight measurement, volume, and distance.
- Ability to apply common sense understanding to carry out detailed but uninvolved written or oral instructions.
- Ability to deal with problems involving a few concrete variables in standardized situations.
- Time management skills.
- Ability to multi-task
- Professionalism
- Must be able to assist with troubleshooting as needed.



## **ENVIRONMENTAL CONDITIONS**

- This position requires continuous temperature changes, working alone, and working with others.
- This position requires frequent work in extreme heat, extreme cold, dryness, or humidity.
- While performing the duties of this job, the employee is regularly exposed to work near moving mechanical parts and outdoor weather conditions.
- This position is regularly exposed to wet or humid conditions (non-weather), work near moving mechanical parts, work in high, precarious places, outdoor weather conditions, extreme cold (non-weather), and extreme heat (non-weather).
- The employee is occasionally exposed to fumes or airborne particles and confined spaces.
- The noise level in the work environment is usually moderate.

## **PHYSICAL DEMANDS**

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job.

- Job regularly required to stand, walk, use hands, reach with hands and arms, climb or balance, stoop, kneel, crouch or crawl, talk or hear, and taste or smell for long periods of time throughout the day.
- Must be able to work outdoors at various times throughout the year.
- Requires manual and bi-manual dexterity, fine and gross motor skills, eye/hand coordination, near vision, hearing and speech.
- The employee must frequently lift and/or move up to 75 pounds. Specific vision abilities required by this job include ability to adjust focus. Requires occasional kneeling and bending.
- Requires occasional walking, reaching above shoulder, pushing, and pulling.
- Requires occasional lifts and carries up to 75 pounds.

Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.
